**WITHDRAWAL OF PETITION TO REVISE DECLARATION OF FULLY APPROPRIATED
STREAM SYSTEMS DESIGNATION OF THE AMERICAN RIVER, SACRAMENTO
COUNTY**

The State Water Resources Control Board (SWRCB) received your letter dated December 14, 2004 to Victoria A. Whitney, Chief of the Division of Water Rights, officially withdrawing the Southern California Water Company's petition to revise the Declaration of Fully Appropriated Stream Systems to allow processing of applications to appropriate treated groundwater discharged into the Lower American River. Accordingly, the petition and accompanying proposed application (X003385) are cancelled. The SWRCB does not intend to take any further action on this matter.
