The West Side Irrigation District hereby requests approval to file the attached *AMENDED* Notice of Intent to Appear in the hearing regarding Administrative Civil Liability against Byron-Bethany Irrigation District. This amendment is necessary because the parties are trying to streamline discovery so that it may affect not only the BBID hearing but also the Cease and Desist Hearing scheduled against The West Side Irrigation District ("WSID"). If WSID will be bound at all through legal or factual determination included in the BBID ACL Hearing, then it must be allowed to fully participate in that hearing.

We do not believe that any party is prejudiced by this action because (1) the hearing has been delayed, (2) BBID and CDWA have been given until October 22, 2015 to file their revised witness lists to identify all witness, and (3) time limits will be imposed by the Hearing Officer.
