Ladies and Gentlemen:

On March 23, 2017, the State Water Resources Control Board (State Water Board) received a request from El Sur Ranch (ESR) for continued abeyance of any further action on Water Right Application 30166. ESR requested an additional 45 days, until May 15, 2017, to conclude settlement negotiations with the California Department of Fish and Wildlife (CDFW). On April 3, 2017, CDFW stated that it did not object to ESR's request for additional time to continue settlement negotiations. No other parties in this matter filed any objections to the request.

By letter dated June 20, 2017, ESR indicated that settlement negotiations with CDFW would be finalized in the very near future and requested a small amount of additional time to finalize and submit the settlement. ESR requested the State Water Board continue to hold this proceeding in abeyance to allow time for the final phase of negotiations. By letter dated June 21, 2017, CDFW stated that the parties continue to make significant progress towards achieving a mutually agreeable solution and it does not object to ESR's request for additional time to complete negotiations.

All other parties in this matter will have until noon, July 10, 2017, to submit objections to ESR's request for additional time to complete settlement negotiations.
