## WATER RIGHT APPLICATION 30166 OF EL SUR RANCH, BIG SUR RIVER IN MONTEREY COUNTY

This letter addresses the request of the California Department of Fish and Wildlife (Department) and El Sur Ranch (Applicant) that the State Water Resources Control Board (State Water Board or Board) hold in abeyance any further action on water right Application 30166 during the pendency of settlement negotiations between the Department and the Applicant.

By letter dated May 20, 2016, the Department and El Sur Ranch advised Mr. Tom Howard, Executive Director of the State Water Board, of their ongoing settlement negotiations and requested that the Board hold in abeyance any further action on water right Application 30166 until the conclusion of these negotiations.

By letter dated June 10, 2016, I directed the Department and the Applicant to submit an estimated time schedule for the conclusion of settlement negotiations. I also directed the Department to submit an update regarding the status of: 1) the physical habitat simulation model study (a component of the Department's instream flow recommendations for the Big Sur River) that was being conducted at the time of the hearing in this matter; 2) the publication of the results of the aforementioned study if applicable; and 3) any final recommendations for proposed streamflow requirements for the Big Sur River pursuant to Public Resources Code § 10002. Lastly, I set a deadline of July 8, 2016, for any hearing party to submit objections to the request for abeyance.

The Department responded by letter dated June 22, 2016, which stated that technical flow criteria reports for the Big Sur River instream flow studies were completed in July 2014 and draft flow recommendations were released in March 2016. The Department anticipates providing final flow recommendations to the State Water Board in the fall of 2016. In a separate letter also dated June 22, 2016, the Department and the Applicant reiterated their request that the State Water Board allow them to complete their settlement negotiations, and suggested that they report to the Water Board no later than December 31, 2016.

The State Water Board did not receive any objections to the request for abeyance. I hereby grant the request to hold any further actions regarding water right Application 30166 in abeyance until the Department and the Applicant have concluded their negotiations, or until December 31, 2016, at the latest.
