Dear Mr. Gilbert:

We are in receipt of your letter, dated January 20, 2002 to Mr. Arthur G. Baggett, Jr. Your letter has been directed to the Division of Water Rights for a response.

In your letter, you requested that the State Water Resources Control Board (SWRCB) hearings on the Imperial Irrigation District/San Diego County Water Authority water transfer be held in El Centro if at all possible. Similar requests to hold at least a portion of the hearing in the Imperial Valley were made by parties attending the January 23, 2002, Pre-hearing Conference in Sacramento. In response to these requests, the SWRCB has scheduled an April 22, 2002 hearing date in Holtville, California. As discussed in the Hearing Notice, which was mailed on February 6, 2002, the April 22 hearing date is expressly reserved for policy statements. If you wish to make a policy statement, please plan on attending the April 22<sup>nd</sup> hearing date or, you may also provide a written policy statement to the SWRCB.

The evidentiary part of the hearing will commence on April 23, 2002, in Sacramento. All of the hearing proceedings will be recorded and transcripts will be available for purchase from the transcriber, Esther Schwartz, of Capitol Recorders, shortly after the proceedings are concluded. Alternatively, the transcripts will be available free of charge on the SWRCB's Internet site 60 days after they are received by the SWRCB.
