NOTICE OF APPROPRIATION OF WATER.

NOTICE IS HEREBY GIVEN, that, in accordance with the provisions of the laws of the State of California respecting WATER RIGHTS, the undersigned, has appropriated and hereby claim 15 inches inches of water, flowing in Gulch fed by Spring on lands owned by Shore & Goforth lands in E $\frac{1}{2}$  of NE $\frac{1}{4}$  Sec 5 Twp 21 N. R. 13 West M.D.M. in the County of Mendocino, State of California, measured under a four-inch pressure.

That the purpose for which the undersigned claims said water is for purpose of irrigation and Domestic purposes on Lands owned by claimant to wit:
