DRAFT DECISION PARTIALLY APPROVING WATER RIGHT APPLICATIONS 31165 and 31370 – SAN BERNARDINO VALLEY MUNICIPAL WATER DISTRICT AND WESTERN MUNICIPAL WATER DISTRICT (MUNI/WESTERN), VARIOUS TRIBUTARY CREEKS, AND THE SANTA ANA RIVER, SAN BERNARDINO AND RIVERSIDE COUNTIES

Enclosed is a draft decision in which the State Water Resources Control Board (State Water Board) partially approves water right Applications 31165 and 31370 of Muni/Western to appropriate water from Bear Creek, Breakneck Creek, Keller Creek, Alder Creek and the Santa Ana River, by direct diversion and storage to groundwater basins for beneficial use within the service area of Muni/Western, in San Bernardino and Riverside Counties.

A State Water Board Public Workshop to receive comments on the draft decision is tentatively scheduled for October 7, 2009 in Sacramento. The State Water Board will issue a public notice of the workshop at least ten days in advance. This notice will include procedures for submitting comments concerning the enclosed draft decision.


