Please find attached the City of Riverside's Application 31372 and Wastewater Change Petition WW-0045 table summaries. Except for the place of use provision, Application 31372 and Wastewater Change Petition WW-0045 are consistent with one another.

The Jurupa Community Services District is located within the Santa Ana River Watershed and is connected to the Riverside Water Quality Treatment Plant. Application 31372 did not include the Jurupa Community Services District as a place of use. However, Wastewater Change Petition WW-0045 does include the Jurupa Community Services District as a place of use. The description provided in Wastewater Change Petition WW-0045 is the correct description for place of use and should supersede the description provided in Application 31372.

Summary of Application 31372**

Applicant: City of Riverside

Source: Treated effluent generated from the City's Regional Water Quality Control Plant. Application 31372 seeks to appropriate treated effluent that is presently discharged to the Santa Ana River, and future increases in treated effluent that would otherwise be discharged to the Santa Ana River.

Point of Diversion: Located N. 656,200 and E. 1,633,300 California Coordinate System, Zone 6, being within the SW ¼ of SE ¼ of Section 25, T2S, R6W, SBB&M.

Priority date: November 6, 2002

Diversion season: January 1 to December 31

Diversion amount: 75 cfs, not to exceed 41,400 acre-feet annually

Purposes of use: Municipal, industrial, irrigation

Place of use: Within the City of Riverside's City Limits and Service Area Boundary

Summary of Petition WW-0045 for Change in Place of Use, Purpose of Use and Discharge Amount of Treated Wastewater

Petitioner: City of Riverside

Point of Discharge:

Present: Located N. 656,200 and E. 1,633,300 California Coordinate System, Zone 6, being within the SW ¼ of SE ¼ of Section 25, T2S, R6W, SBB&M.

Proposed: Same

Place of Use:

Present: 41 acres at the Van Buren Golf Center and about 10 acres at the Van Buren median and frontage (Urban Forest); industrial use at the Toro Manufacturing Company.

Proposed: Numerous schools, cemeteries, golf courses, parks, landscaped areas, and greenbelts, and process water uses at various industries, all within the City of Riverside's City Limits and Water Service Area Boundary, and within the boundary of the Jurupa Area Plan, as shown on the map accompanying this petition, and as further identified in the City of Riverside's Recycled Water Phase 1 Feasibility Study and Citywide Master Plan (September 2003); agricultural irrigation of about 5,600 acres of citrus orchards and nurseries within the aforementioned boundaries.

Purpose of Use:

Present: Irrigation, industrial

Proposed: Municipal and industrial, irrigation

Amount discharged to Santa Ana River:

Present: About 36,000 acre-feet annually

Proposed: Minimum 25,000 acre-feet annually; estimated long-term of 26,000 acre-feet annually
