Re: ENF01951 and ENF01949 Objections to Prosecution Team Proposal

Dear Hearing Officers Doduc and Spivy-Weber:

The Byron Bethany Irrigation District (BBID) does not object to a combined proceeding for the purpose of addressing the issue of the availability of water for BBID to divert under its pre-1914 appropriative water right. BBID does object to the scope of such a proceeding as articulated by the Prosecution Team, the California Department of Water Resources, and the State Water Contractors.

The Prosecution Team accuses BBID of violating California Water Code section 1052 (Section 1052). Section 1052 provides, in pertinent part:

The diversion or use of water subject to this division other than as authorized in this division is a trespass.

The Prosecution Team alleges BBID violated Section 1052 because there was no water available for BBID to divert under its priority of right. The appropriate question is not whether the methodology "employed" by SWRCB staff was "adequate," but is whether there was actually insufficient water for BBID to divert at its point of diversion between June 13 and June 25, 2015.

In order to make such a determination, the Prosecution Team will need to prove that the sources of water contributing to the water supply in the vicinity of BBID's point of diversion were insufficient to supply a pre-1914 appropriator of BBID's priority. The Prosecution Team must also prove that any water in the vicinity of BBID's point of Diversion that was available for appropriation by diverters "senior" to BBID was actually

needed by those senior appropriators and that those senior appropriators were injured by BBID's diversion of water.

Thus, the appropriate issues for a combined proceeding are:

- What are the sources of water present at the BBID and West Side Irrigation District (WSID) points of diversion during the periods of alleged violations?
- What are the senior demands in the vicinity of the BBID and WSID points of diversion?

The burden of proof rests with Prosecution Team to prove that there was no water available at the BBID and WSID points of diversion during the period of alleged violation and that, to the extent water was available, that any such water was required to meet senior water right demands and that diversion of water by BBID and/or WSID caused injuries to those senior water right holders.
