NOTICE OF MINOR CHANGE REQUEST FOR PERMIT 19725 (APPLICATION 25079)

COUNTY: Marin

STREAM SYSTEM: Lagunitas Creek

North Marin Water District has filed a request for a minor change under Water Code section 1700.6, seeking to add a point diversion within of SW $\frac{1}{4}$ of SE $\frac{1}{4}$ of projected Section 8, T3N, R8W, MDB&M. Source: Lagunitas Creek

Points of Diversion:

- 1) **Coast Guard Well 1:** By California Coordinate System of 1983, Zone 3, North 2,219,905 feet, and East 5,900,081 feet, being within SW $\frac{1}{4}$ of SE $\frac{1}{4}$ of projected Section 25, T3N, R9W, MDB&M.
- 2) **Coast Guard Well 2:** By California Coordinate System of 1983, Zone 3, North 2,219,909 feet, and East 5,900,069 feet, being within SW $\frac{1}{4}$ of SE $\frac{1}{4}$ of projected Section 25, T3N, R9W, MDB&M.
- 3) **Coast Guard Well 3:** By California Coordinate System of 1983, Zone 3, North 2,219,912 feet, and East 5,900,050 feet, being within SW $\frac{1}{4}$ of SE $\frac{1}{4}$ of projected Section 25, T3N, R9W, MDB&M.
- 4) **Downey Well:** By California Coordinate System of 1983, Zone 3, North 2,222,409 feet, and East 5,901,065 feet, being within SE $\frac{1}{4}$ of NE $\frac{1}{4}$ of projected Section 25, T3N, R9W, MDB&M.
- 5) **Gallagher Well No. 1:** By California Coordinate System of 1983, Zone 3, North 2,223,665 feet, and East 5,904,382 feet, being within SE $\frac{1}{4}$ of NW $\frac{1}{4}$ of projected Section 30, T3N, R8W, MDB&M.

Purpose and Place of Use:

Authorized uses of water are Municipal uses at the Annexation No. 3 service area of the North Marin Water District within Township 2N and 3N, Range 8W and 9W, MDB&M, as show on map dated February 7, 2007, filed with the State Water Board.

Diversion Season and Amount:

Nine hundred sixty-one thousandths (0.961) cubic foot per second to be diverted from January 1 to December 31 of each year. The maximum amount diverted under this license shall not exceed 292.5 acre-feet per year.

In a dry year, the maximum simultaneous rate of diversion under this license and the rights pursuant to Applications 13965B and 25062 shall not exceed 1.18 cubic feet per second.

Requested Minor Change:

Add a point of diversion (Gallagher Well No. 2) within the SW $\frac{1}{4}$ of SE $\frac{1}{4}$ of projected Section 8, T3N, R8W, MDB&M.
