Description of Nature, Purpose, and Beneficiaries of Project: KRCD owns and operates the Jeff L. Taylor – Pine Flat Hydroelectric Project, which generates 373.32 megawatts of energy from three powerhouse turbines fed by water released from Pine Flat Dam on the Kings River. KRCD seeks to construct a new low-flow powerhouse on an existing bypass pipe that will increase the nameplate generation capacity of the Jeff L. Taylor – Pine Flat Hydroelectric Project by 3.8 percent from flows that are currently too low for the existing generators. The new powerhouse will not increase the diversion capacity or hydraulic capacity of the existing Jeff L. Taylor – Pine Flat Hydroelectric Project. On December 21, 2021, KRCD applied for an amendment of its Federal Energy Regulatory Commission license and an associated water quality certification from the State Water Resources Control Board (State Water Board) for the proposed work. KRCD filed a Notice of Exemption as lead agency on May 18, 2022. This Notice of Exemption is for the State Water Board's approval, as a responsible agency, of the water quality certification for the license amendment.
