The Project is needed to address significant damage to Flowline Line No. 1 and diversion structures resulting from the 2020 Apple Fire. Flowline Line No. 1 and the diversion structures are part of the San Gorgonio 1 and 2 Hydroelectric Project, Federal Energy Regulatory Commission (FERC) Project No. 344. SCE proposes to transfer some of the San Gorgonio 1 and 2 Hydroelectric Project water conveyance system to the San Gorgonio Pass Water Agency, Banning Heights Mutual Water Company, and the City of Banning, which will support their water resilience. The repairs will not increase the flowline's hydraulic capacity.
