**PROJECT DESCRIPTION:** Sacramento Municipal Utility District (SMUD) has requested a one-time variance to the reservoir elevation level requirements of Condition 5 of the Upper American River Project (UARP) water quality certification [Federal Energy Regulatory Commission (FERC) Project No. 2101]. SMUD proposes to begin reservoir drawdowns in August 2017. Upon maintenance completion, the reservoirs will gradually refill as the winter storms begin. No impacts to beneficial uses are anticipated.

The proposed variance at Loon Lake Reservoir will facilitate necessary maintenance at the boat ramp. Per consultation between SMUD and the United States Forest Service, the Loon Lake boat ramp has been identified as a heavy maintenance priority for 2017.

Following inspections in 2016, both the FERC and the California Department of Water Resources' Division of Safety of Dams have issued orders directing SMUD to repair or replace the toe drain to control seepage at Ice House Reservoir.
